


# TRAININGS

Under the guidance of Debra Mayes, OCCD Training Coordinator and Jack Riordan, OCCD Community Development Specialist, the 2017/2018 OCCD Year was a busy one with eleven (11) training offered around the state and attended by over seven hundred fifty (750) members and non-members under the ODSA FY17 Training & Technical Assistance Grant.

One hundred fifty-nine (159) took advantage of the *HUD* **CDBG Basics** hosted by Stark County Metropolitan Housing Agency, Ohio Capital Corporation for Housing and Montgomery County providing their Business Solutions Center in Dayton. Providing this training, as well as the June **HOME** training in Columbus, were ICF International staff, Les Warner and Shawna Moraille.

OCCD co-sponsored the ODSA **OCEAN** training in four locations around the state to nearly one hundred seventy (170) of their grantees.

Sawmill Creek in Huron provided the setting once again for the **ODSA Development Conference** co-sponsored by OCCD in November. Over one hundred fifty (150) grantees enjoyed the beautiful fall grounds and wide ranging subject matter. OCCD was pleased to invite Diane Taylor, Executive Director of the Council of State Community Development Agencies (COSCDA) to speak during lunch on updates on the federal budget, legislative developments and relevant U.S. Department of Housing and Urban Development initiatives.

Rounding out OCCD sponsored trainings were **Davis Bacon** presented by Deborah Diaz, HUD Chicago and **Rehab Specialist** training overseen by ODSA staff.

OCCD membership was represented by staff at the 2017 Ohio Housing Conference in Columbus participating with a sponsored display distributing membership brochures, newsletters and promoting the training opportunities available through OCCD.
