Ohioans have been receiving their invitations to participate in the Census by mail. The 2020 Census is modern and technology will allow Ohioans many ways to respond. The quickest and easiest is online at 2020Census.gov. The site will accept responses in English and 12 non-English languages. Ohioans can also complete the survey by phone.

Participation in the 2020 Census is critical, and you can track your community's participation rate by visiting the 2020 Census website. On this site you can view response rates at the

county, city or township level. This is important data as we work to make sure every Ohioan is counted.

Please continue to remind your residents to participate in the 2020 Census. It's something they can do while following the Governor's stay at home order during this health crisis. Remember, the Census will take 10 minutes, but it impacts the next 10 years. The 2020 Census is easy, safe, and important.
