Revised: HOME Program Project Draws and Adjustment Restriction

OCD issued a revised version of Program Policy 19-05: HOME Program Project Draws and Adjustment Restriction. Under the revised policy, grantees will not be able to draw returned HOME funds for one project to use on another project. Returned HOME funds will be cancelled from the grant. PY 2020 Critical Infrastructure Program Round 2

Eligible applicants interested in applying for Round 2 PY 2020 Critical Infrastructure Program funding are required to submit a pre-application to OCD for review by **December 16, 2020**. Upon approval, OCD will open a full application for the applicant in OCEAN to submit by **January 13, 2021**.
