Grant Administration Updates

PY 2020 Critical Infrastructure Program Round 2

Eligible applicants interested in applying for Round 2 PY 2020 Critical Infrastructure Program funding are required to submit a pre-application to OCD for review by **December 16, 2020**. Upon approval, OCD will open a full application for the applicant in OCEAN to submit by **January 13, 2021**. OCD will accept pre-applications on a rolling basis and will consider new requests until all available PY 2020 funds are expended. To access the pre-application, click <u>here</u>.
