Semi-Annual Labor Standards Enforcement Reports Due Wednesday

For the reporting period April 1, 2020 to September 30, 2020, grantees must enter Notice of Contract Award (NOCA) data in OCEAN and submit Semi-Annual Labor Standards Enforcement Report (SALSER) forms via email to Sheilah Bradshaw by **Wednesday**, **September 30, 2020**. Census 2020 Deadline is Wednesday

The deadline for people to submit their 2020 Census form is this coming Wednesday, September 30, 2020. The state is currently at a 70.2% self-response rate. Please continue to remind residents in your community to participate in the Census. It takes 10 minutes, but it impacts the next 10 years. The Census is easy, safe, and important. You can track your community's participation rate by visiting the 2020 Census website. On this site you can view response rates at the county, city or township level. Emailed OCEAN User Agreements Requests Now Accepted

Effective immediately, OCD is no longer requiring grantees to mail a hard copy of the completed OCEAN User Agreement form. Grantees will need to continue to have the form **signed by the chief elected/executive official and notarized** for OCD to accept an electronic submission. Completed forms should be emailed to ocd@development.ohio.gov. For the updated form and instructions, click here.
