Administrative Updates

New Community Development Analyst – Grant Johnson

Grant Johnson joined Development as a Community Development Analyst in the Office of Community Development on April 19, 2021. Prior to joining Development, Grant worked at the Henrico County Department of Community Revitalization in Virginia where he received and reviewed applications, administered housing rehabilitation and emergency housing repair programs and helped draft the county's Consolidated Plan and Annual Action Plan. Grant holds a Master of Public Administration from Marshall University and bachelor's degrees in political science and economics from Old Dominion University. Guidance for Street Improvements Now Available

To provide clarity for grantees on street improvement projects, OCD created a guidance document that covers resurfacing, street rehabilitation and full-depth reconstruction activities. Street resurfacing (paving) is not eligible through the Allocation or Critical Infrastructure Programs and can be funded <u>only</u> as a component of a targeted Neighborhood Revitalization Program. Street reconstruction is eligible as an Allocation, Neighborhood Revitalization or Critical Infrastructure project. For more detailed information, click <u>here</u>.

PY 2021 Neighborhood Revitalization and Critical Infrastructure Programs Pre-Applications Now Available

The Neighborhood Revitalization and Critical Infrastructure Programs pre-applications are now available on the TA site. Applicants can submit pre-applications beginning May 10, 2021. Pre-applications must be received by June 4, 2021, for both the Neighborhood Revitalization Program and Round 1 of the Critical Infrastructure Program. PY 2021 Income Limits Now Available

Income limits for PY 2021 are now available on the TA site. Each year, HUD sets income limits that determine eligibility for assisted housing programs and develops income limits based on Median Family Income estimates and Fair Market Rent area definitions for each metropolitan area, parts of some metropolitan areas, and each non-metropolitan county. These limits go into effect April 1 each year. Grantees should begin using the PY 2021 Income Limits immediately. To access the PY 2021 Income Limits, click <u>here</u>.

- Type and quantity of PPE requested
- Contact information
 - Names of your organization's contact person. (ODPS suggests multiple contacts)
 - Contact(s) phone number or email address
 - o Organization's hours of operation and any special delivery instructions
 - Date and time of pick up or delivery

- For PPE deliveries, answer the following questions:
 - Is there a loading ramp at the delivery location?
 - Does the delivery location have personnel to unload the PPE?
 - Does the delivery location have equipment to unload the PPE?
