Grantees may view and download Project-Specific Release of Environmental Conditions documents in OCEAN. OCD will not mail hard copies of these documents. Round 1 Emergency Solutions Grant CARES Act (ESG-CV) Program Phase 2 Funding Availability

As part of Round 1 of the Emergency Solutions Grant CARES Act (ESG-CV) Program, the Office of Community Development reserved funding for a second phase to address continuing support in target areas that need it most as a result of the ongoing COVID-19 pandemic. **Phase 2 funding is only available to current Round 1 ESG-CV grantees.** For more information, click here.

Administrative Updates

Reminder for PY 2020 Community Development Program Grantees

Grantees must submit a Request for Release of Funds (RROF) and/or Environmental Review Certification by **February 15**, **2021** for all PY 2020 Community Development Program activities not included in the Environmental Review Documentation and Certification Form for General Administration, Fair Housing, and Planning. Failure to meet the February 15, 2021 deadline may reduce the likelihood OCD will approve any request for extension or amendment of the grant agreement. Failure to meet the February 15, 2021 deadline will also affect the Grantee's administrative capacity rating, which may impact the Grantee's ability to apply successfully for competitive OCD-funded programs.

Notice of Funding Availability Changes

Beginning in PY 2021, OCD will post one officewide Notice of Funding Availability (NOFA) for all its funding sources and programs. The NOFA will be updated regularly to reflect changes in program allocations and state and federal funding amounts. Citizen Participation Requirements for PY 2021

For all grantees applying for OCD grants in PY 2021, the citizen participation requirements are back to the 30-day minimum for public comment periods per HUD regulations. We encourage grantees to hold public hearings virtually, however, grantees must provide the community with reasonable notice and opportunity to comment. Limited PPE available through the Ohio Department of Public Safety

The Ohio Department of Public Safety (ODPS) has a limited quantity of personal protective equipment (PPE) available to communities and nonprofit organizations. To request PPE, email esf6@dps.ohio.gov with the following information:

- Type and quantity of PPE requested
- Contact information
 - Names of your organization's contact person. (ODPS suggests multiple contacts)
 - Contact(s) phone number or e-mail address
 - o Organization's hours of operation and any special delivery instructions
 - Date and time of pick up or delivery
 - For PPE deliveries, answer the following questions:
 - Is there a loading ramp at the delivery location?
 - Does the delivery location have personnel to unload the PPE?
 - Does the delivery location have equipment to unload the PPE?
