PY 2020 Round 2 Emergency Solutions Grant CARES Act (ESG-CV) Program Funding Availability

For the reporting period October 1, 2020 to March 31, 2021, grantees must enter Notice of Contract Award (NOCA) data in OCEAN and submit Semi-Annual Labor Standards Enforcement Report (SALSER) forms via email to Sheilah Bradshaw by **Wednesday, March 31, 2021**. PY 2020 Critical Infrastructure Round 2 Awards Online

OCD awarded \$5,106,200 to 9 communities for the completion of 11 public facility improvement projects through Round 2 of the PY 2020 Critical Infrastructure Program. Awardees expect to improve four water facilities, four flood and drainage facilities, two sewer facilities, and one

bridge replacement project. The applications leverage approximately \$2.8 million in other public and private funds, including \$17,634 from local Community Development Block Grant (CDBG) Economic Development Revolving Loan Funds (RLF). For more information, click <u>here</u>.

Citizen Participation Requirements for PY 2021

For all grantees applying for OCD grants in PY 2021, the citizen participation requirements are back to the 30-day minimum for public comment periods per HUD regulations. We encourage grantees to hold public hearings virtually, however, grantees must provide the community with reasonable notice and opportunity to comment.  - o Organization's hours of operation and any special delivery instructions
 - Date and time of pick up or delivery
 - For PPE deliveries, answer the following questions:
 - Is there a loading ramp at the delivery location?
 - Does the delivery location have personnel to unload the PPE?
 - Does the delivery location have equipment to unload the PPE?
