

Nominations from the Floor:

#### Bylaw Change

Due to members shifting jobs and the Board losing potential officer and board member candidates, the Board draft changes to Article V. Elected Officers, Terms and Duties, Section 1. Board of Directors, B. Composition.

The proposed changes (in red) to the OCCD Bylaws are reflected below:

B. Composition. The Board of OCCD will consist of an odd number of OCCD Full Subscription Members totaling no less than 13 (9) and no more than 17 (15). In addition, the Board must be representative of the membership with the following limitations:

- 1. No more than 33% (thirty-three percent) of the Board may be from nongovernmental agencies.
- 2. No more than 25% (twenty-five percent) of the Board may be ex-officio (past president members.
- 3. When determining the number of persons for B.1 and B.2 a portion of a person will not be added; i.e. 25% of 17 (15) would be 4.25 (3.75) persons this would result in 4 (3) persons. The numbers will not be rounded up, but will be the total of whole persons.

The Full Board endorsed these changes to send to the membership.
